REPORT OF ROUTINE SIX-YEAR SURVEY VISIT MCLENNAN COMMUNITY COLLEGE AT WACO, TEXAS MULTIPLE ENTRY-EXIT PROGRAM VOCATIONAL NURSING EDUCATION

SUMMARY OF REQUEST:

Consider the report of the routine six-year survey visit of the Multiple Entry-Exit Program at McLennan Community College at Waco, Texas.

HISTORICAL PERSPECTIVE:

- Preliminary NCLEX-PN® examination pass rate for 2008 is 100% (22/22). The examination year ends December 31, 2008.
- McLennan Community College Associate Degree Program (ADN) added the Multiple Entry-Exit
 Option (MEEP) in 1976. A MEEP option prepares students in an Associate Degree Nursing
 Educational Program with additional course work and clinical experiences to allow them to take the
 NCLEX-PN® examination at a point during their educational program.
- The last routine six-year survey visit was conducted in February 2001.
- Routine survey visits to the traditional McLennan Vocational Nursing Educational Program and the MEEP were scheduled together on September 29-30, 2008.
- BON survey visitors were Janice Hooper, PhD, RN and Virginia Holmes, MSN, RN.

SUMMARY OF SURVEY VISIT:

- McLennan Community College is located at 1400 College Drive in Waco, Texas.
- Melesia Henry, MSN, RN is the new director of the ADN Program at McLennan Community College and also directs the MEEP Option.

Activities During Survey Visit

Board staff:

- Met with college administrators in regards to both traditional VN and MEEP programs.
- Interviewed Director: Melesia Henry, MSN, RN who directs the ADN program and the MEEP option.
- Interviewed 3 students who had completed the MEEP option and had passed the licensure examination. They are presently working part time as licensed vocational nurses while completing their associate's degree in nursing.
- Reviewed VNSG 1463, the required course taken by students completing the MEEP option.
- Reviewed other documents supplementing the course and student assignments.
- Tour of college facilities had been accomplished for VN program visit.
- Conducted a summary conference with administration and directors for VN and MEEP programs.

Survey Visit Findings

Positive Findings:

 Students who wish to complete the MEEP option take VNSG 1119, the VN role course with the students in the traditional VN program

- The director carefully screens all students interested in taking VNSG 1463, a 6-week intensive clinical course during the second summer session of the ADN program.
- VNSG 1463 provides a six-week, five day a week, 8 hour day clinical experience under close faculty supervision.
- Students in this clinical course will care for up to 3 patients each.
- The clinical evaluation tool is competency-based and allows the faculty to evaluate the students skill level for their readiness to apply to take the NCLEX-PN examination.
- The director reports that students who take this course perform better in the second year of the ADN program.
- The students confirmed the rigor and value of this clinical course.

Area of Concern:

- No formal evaluation of the MEEP program is in place.
- Decisions about VNSG 1463 or the MEEP option are made at the ADN level. No minutes related to discussing this program were reviewed.

PROPOSED COMMENDATIONS:

- The director of the MEEP program is commended for her excellent leadership and dedication to the program.
- 2. The program is commended for the excellent clinical experiences for the MEEP students.
