# Consideration of Change in Approval Status From Full Approval to Full Approval with Warning Vernon College at Wichita Falls in Wichita Falls, Texas Vocational Nursing Education Program

## **Summary of Request:**

Consider the proposed change in approval status for Vernon College at Wichita Falls Vocational Nursing (VN) Education Program in Wichita Falls, Texas from Full Approval to Full Approval with Warning based upon the 2016 NCLEX-PN® examination pass rate, findings in the Self-Study Report dated July 2016, and areas for improvement to align with Rule 214.

## **Historical Perspective:**

- Vernon College was established in 1970 as Victoria Regional Junior College.
- Vernon College has campuses in Wichita Falls, Vernon, and Seymour, Texas.
- The VN Program combined with Bethania School of Vocational Nursing in Wichita Falls in 1976.
- Vernon College is accredited by the Southern Association of Colleges and Schools Commission on Colleges.
- Sherrie Denham, RN, MSN is the Program Director for the VN program and was appointed in 2015.
- The NCLEX-PN® examination pass rates for the past five years are included in the table below:

- Due to the 2015 NCLEX-PN® examination pass rate of 73.81%, the Program Director and faculty were required to submit a Self-Study Report (SSR) that evaluated factors that contributed to the graduates' performance on the NCLEX-PN® examination and offering descriptions of corrective measures to be implemented.
- The faculty identified factors in the SSR that may have contributed to the decline in the pass rate and designed corrective measures to be implemented that included:
  - increasing the minimum passing score from 75 to 78%;
  - reassessing and revising re-entry policy for failures/withdrawals;
  - making attendance policy more rigorous;
  - increasing usage of simulation; and

- > encouraging faculty to develop exams rather than relying on test banks.
- The program has provided a response to the Board with updates of their corrective measures (See Attachment #1).

#### **Rationale for Recommendations:**

Rule 214.4(c)(3)(A) states: "A warning may be issued to a program when the pass rate of first-time NCLEX-PN® candidates ... is less than 80% for two consecutive years..."

The Education Guideline for writing a Self-Study Report requires that "The effects of the corrective measures should be evaluated as a part of the Total Program Evaluation Plan."

#### **Staff Recommendation:**

Move to change the approval status for the Vernon College at Wichita Falls Vocational Nursing (VN) Program in Wichita Falls, Texas from Full Approval to Full Approval with Warning based upon the 2016 NCLEX-PN® examination pass rate, findings in the 2016 Self-Study Report, and areas for improvement to align with Rule 214, and impose the conditions and requirements in the attached letter and Board Order (See Attachment #2).

To Whom It May Concern:

The Vocational Nursing program at Vernon College appreciates this opportunity to address the Board relating to the motion to change the Vocational Nursing program status from full accreditation to full accreditation with warning based upon the 2015 NCLEX pass rate of 74%. Program faculty completed a self-study in July of 2016 to identify the factors that adversely impacted the program pass rate.

During the self-study several mitigating factors were noted including: ease of re-entry of students, ease of course substitution, and lax extenuating circumstances and attendance policies. Historically students who failed a course were allowed to re-take the failed course. If the student passed the course upon the second attempt they were allowed to re-enter the program and progress to the next program level with no ramifications.

Additionally, students who violated the attendance policy were allowed to re-enter the program if they claimed extenuating circumstances. However, the extenuating circumstance policy required the student to provide proof of adversity such as medical issues (hospitalization). We were not requiring the students to adhere to the policy as anyone who claimed extenuating circumstances were allowed to reenter without appropriate documentation. Program administration were participating in policy violation. During the self-study it was noted that the majority of re-entry students failed the NCLEX upon the first attempt regardless of reason for re-entry.

The ease of course substitution was another factor identified during the self-study. Students were allowed to transfer the following courses into the program Anatomy and Physiology, Growth and Development, Psychology, Nutrition, and Microbiology. These courses were allowed to transfer regardless of length of time elapsed from the time the course was taken in relation to program start date. Vernon College allows course transfer with no time limit imposed upon course transfer and we operated upon the same policy. This ease of course transfer has been detrimental to the pass rate.

The following corrective measures have been implemented to improve the pass rate. The attendance policy has been strengthened. Previously students were allowed to miss 60 hours per year. This was problematic as students would miss one class to study for another one. In order to mitigate this the program changed the attendance policy. Students are now allowed to miss two days in the fall, spring and one day in the summer semesters. This has stopped the leaving one class in order to study for another one.

The program changed the grading policy in order to increase the rigor of the program. Historically the pass rate was 75%. It has been increased to 78%.

The program has changed the course substitution policy. The policy now states that courses may only be transferred into the program if they have been taken within 3 years of program start date. This policy takes precedence over Vernon College's policy of accepting courses without time constraint.

The extenuating circumstance policy has been reviewed by faculty and program administration. Program administration and all staff and students are in compliance with the policy. Students who provide documentation of extenuating circumstances and are passing all courses with a 78 or greater are allowed re-entry. The extenuating circumstance policy is allowed only once during program duration regardless of cause. We have ceased re-entry for any student due to course failure.

The faculty are implementing all policy changes and will continue to implement corrective measures in order to improve student success on NCLEX. We anticipate that these changes will positively impact the 2016-2017 cohort. Faculty staff, program administration and the administration of Vernon College are committed to enhancing student success. We welcome all input that the Texas Board of Nursing can provide and are confident that we can improve NCLEX pass rates.

Admin. Code Chapter 214, based upon the NCLEX-PN® examination pass rate for 2016, findings in the Self-Study Report, and areas for improvement to align with Rule 214.
