

ELIGIBILITY AND DISCIPLINARY COMMITTEE REPORT FOR June 9, 2020 and August 18, 2020

The Eligibility and Disciplinary Committee (Committee) convened on June 9, 2020 and August 18, 2020. This report collectively summarizes the matters and decisions made at the time of the meeting¹.

Petitioners for Licensure

No petitions for licensure were considered by the Committee.

Petitioners for an Exception to a Previous Board Order

The Committee considered eight (8) petitions for an exception to a previous board order:

1. The Committee met to review the material submitted by Petitioner and Staff. Petitioner requested an Exception to a previous Board Order dated October 26, 2017, requesting an unencumbered license. It was the Committee's decision to **deny** the request.
2. The Committee met to review the material submitted by Petitioner and Staff. Petitioner requested an Exception to a previous Board Order dated February 12, 2019, requesting an unencumbered license. It was the Committee's decision to **deny** the request.
3. The Committee met to review the material submitted by Petitioner and Staff. Petitioner requested an Exception to a previous Board Order dated November 14, 2017, requesting an unencumbered license. It was the Committee's decision to **deny** the request.
4. The Committee met to review the material submitted by Petitioner and Staff. Petitioner requested an Exception to a previous Board Order dated November 28, 2018, requesting an unencumbered license. It was the Committee's decision to **deny** the request.
5. The Committee met to review the material submitted by Petitioner and Staff. Petitioner requested an Exception to a previous Board Order dated March 13, 2018, requesting an unencumbered license. It was the Committee's decision to **deny** the request.
6. The Committee met to review the material submitted by Petitioner and Staff. Petitioner requested an Exception to a previous Board Order dated September 10, 2019, requesting the supervision requirement to be removed or Stipulation IV, Sections A & B be waived. It was the Committee's decision to **deny** the request.
