

ELIGIBILITY AND DISCIPLINARY COMMITTEE REPORT FOR September 13, 2022 and November 8, 2022

The Eligibility and Disciplinary Committee (Committee) convened on September 13, 2022 and November 8, 2022. This report collectively summarizes the matters and decisions made at the time of the meeting¹.

Petitioners for an Exception to a Previous Board Order

The Committee considered seven (7) petitions for an exception to a previous board order:

1. The Committee met to review the material submitted by Petitioner and Staff. Petitioner requested an Exception to a previous Board Order dated March 27, 2020, requesting early release from the Texas Peer Assistance Program for Nurses. It was the Committee's decision to **grant** the request.
2. The Committee met to review the material submitted by Petitioner and Staff. Petitioner requested an Exception to a previous Board Order dated August 18, 2020, requesting an unencumbered Texas license based on her nursing practice in Georgia. It was the Committee's decision to **continue** the request until required documentation is received and authority given to the Executive Director to render the final decision.
3. The Committee met to review the material submitted by Petitioner and Staff. Petitioner requested an Exception to a previous Board Order dated December 10, 2019, requesting early release from the Texas Peer Assistance Program for Nurses pursuant to Texas Occupations Code 301.257. It was the Committee's decision to **grant** the request.
4. The Committee met to review the material submitted by Petitioner and Staff. Petitioner requested an Exception to a previous Board Order dated February 27, 2020, requesting early release from the Texas Peer Assistance Program for Nurses pursuant to Texas Occupations Code 301.257. It was the Committee's decision to **deny** the request.
5. The Committee met to review the material submitted by Petitioner and Staff. Petitioner requested an Exception to a previous Board Order dated September 24, 2018, requesting the Board re- evaluate her Texas Peer Assistance Program for Nurses participation pursuant to Texas Occupations Code §301.257. It was the Committee's decision to **grant** the request.
6. The Committee met to review the material submitted by Petitioner and Staff. Petitioner requested an Exception to a previous Board Order dated December 14, 2021, requesting removal of the supervision requirement: an unencumbered license. It was the Committee's decision to **grant** an unencumbered license.
