## Highlights of the 2011 Professional Practice Accountability Survey Results Detailing Registered Nurses' Understanding of Nursing Laws and Regulations

In the July 2011 edition of the *Texas Board of Nursing Bulletin* (Bulletin), registered nurses (RNs) were requested to take part in the *Professional Practice Accountability: Law and Regulation Online Survey*. The purposes of the survey were to: obtain demographic information on survey participants, and determine RNs' understanding of the laws and regulations affecting nursing practice in Texas. The *Nursing Practice Act, Nursing Peer Review, Nurse Licensure Compact, & Advanced Practice Registered Nurse Compact* (NPA), as amended 2009, was used to create the questionnaire and statements.

In July 2012, licensed vocational nurses in Texas will be asked to participate in a study examining understanding of nursing laws and regulations. See the July 2012 *Bulletin* for further information.

Generational cohorts, categorized as the Silent Generation (1922-1945), the Baby Boomers (1946-1964), the Generation X (1965-1980) and the Millennial Generation (1980-2000), were used as the independent variable for the study. These cohorts exhibited each generation's understanding of the requirements for maintaining RN licensure and knowledge of state and federal laws and rules that impact nursing practice.

## Bulletin Readers Invited to Comment on BON's Newsletter, Website, and Customer Service Department

The Texas Board of Nursing (BON) needs stakeholder feedback concerning communication and interaction with the Board. The survey will be posted on the BON website from April 1, 2012 until May 1, 2012. Individuals who are unable to

access the BON website may contact the Board by telephone [(512) 305-7400] and request a copy of the survey form by mail. Data collected through the survey will be used in the development of the Customer Service Report to be included in the agency's Strategic Plan for 2013-2017. The Strategic Plan will be submitted to the Texas Legislature in June 2012. Survey data received through the website and by mail will also be summarized and presented at the July 2012 quarterly Board meeting and published in the October 2012 *Bulletin*. A total of 2,931 RN responses were included in the study, in which 92% were females and 8% were males, with a mean age of 53 years. The majority of the RNs surveyed were Caucasian (74%); 10% were Hispanic; 7% were African American, American Indian, Asian/Pacific Islander; and 9% were identified as "other". Forty-five percent were diploma or associate degree nursing graduates. An additional 36% indicated having a baccalaureate degree, 16% percent with a master's degree, and 3% with a doctoral degree. Those employed in nursing numbered 67%, while 4% were employed in a field other than nursing, and 14% were inactive or unemployed. Seventeen percent had been practicing less than 10 years; whereas, 25% had practiced for 10 to 19 years and 58% had practiced more than 20 years. The

## Advisory Committee Updates

### Deferred Disciplinary Action Pilot Program Advisory Committee

During the 81st Legislative Session, the Texas Legislature enacted Senate Bill (SB) 1415. SB 1415 was designed to explore the effect of a less punitive disciplinary option for nurses who commit minor violations of the Nursing Practice Act and the Board of Nursing (Board) rules. Specifically, SB 1415 authorized the Board to develop and implement a deferred disciplinary action pilot program. One of the primary purposes of the pilot program is to evaluate the effectiveness and efficiency of deferred discipline, in comparison to the Board's more traditional disciplinary processes. The deferred disciplinary action pilot program began on February 1, 2011.

In January, 2011, the Board formed a new advisory committee, the Deferred Disciplinary Action Pilot Program Advisory Committee (Committee), to oversee the pilot program and to evaluate the program's effectiveness and efficiency. The Committee has taken a proactive role in obtaining information and feedback from participants in the pilot program. The Committee is particularly interested in obtaining information and feedback from employers in order to gauge the effectiveness and efficiency of the program from an employer's perspective.

If you are a Texas employer and have employed or retained a nurse who has been the subject of a deferred disciplinary order from the Board, the Committee would like to extend an invitation to you to participate in a short survey. The survey questions are intended to elicit input from employers as to the pilot program's necessity, effectiveness, usefulness, and efficiency. ### Advisory Committee on Education

The Texas Board of Nursing (Board) Advisory Committee on Education (ACE) met on March 7, 2012 to consider the Board's charge from the October 2011 Board Meeting. Discussion included the historical framework of the charge regarding rule development on: the use of preceptors in nursing education; elimination of petitions for waiver; strengthening requirements for program proposals; extension sites/campuses; online instruction; articulation agreements; and geriatric and end-of-life care in professional nursing education programs. ACE members also selected a chairperson for the committee, LeAnn Wagner, MSN, RN. Ms. Wagner is Director of Nursing at Victoria College.

## Summary of Actions

A regular meeting of the Board of Nursing was held January 19-20, 2012, in Austin. The following is a summary of Board actions taken during this meeting.

In the January 13, 2012 issue of the *Texas Register*, the Texas Board of Nursing (Board) published as adopted amendments to §217.6 relating to *Failure to Renew License* without changes to the proposed text as published in the November 25, 2011 issue of the *Texas Register* (36 TexReg 7957). Board Rule §217.6 sets forth the Board's requirements for reactivating an expired or delinquent license. The amendments were enacted to implement the requirements of Senate Bill (SB) 1733, enacted by the 82nd Legislature, Regular Session, effective June 17, 2011. New §217.6(j) establishes two exemptions for military spouse applicants. New §217.6(j)(1) exempts military spouse applicants from paying the late fees and fines required by §217.6 if the applicant submits the following information to the Board: a completed reactivation

application, in paper form, that meets the requirements of §217.6; and documentation showing that the applicant is the spouse of an individual serving on active duty as a member of the armed forces of the United States. New §217.6(j)(2) exempts military spouse applicants from completing the continuing education contact hours required by §217.6 if an applicant has practiced nursing in any jurisdiction within the four years immediately preceding the submission of a reactivation application. All other requirements of §217.6 are applicable to military spouse applicants.

Also in the January 13, 2012 issue of the *Texas Register*, the Board published as adopted new §217.9 relating to *Inactive Status*, without changes, as published in the November 25, 2011 issue of the *Texas Register* (36 TexReg 7961). The amendments are necessary to implement

the requirements of SB 193, enacted by the 82nd Legislature, Regular Session, effective September 1, 2011. Amendments to §217.9: eliminate the current age requirement for placing a nursing license in retired status; implement the requirements of SB 193 relating to "good standing"; clarify the Board's existing procedures and requirements for placing a license in inactive, retired, or volunteer retired status; prescribe additional titles that an individual may use in connection with a retired license; eliminate redundancy within the section; update the Board's website address; add clarifying language regarding the Board's existing reactivation requirements; update references to Board rules within the section; and renumber the section appropriately. Amended §217.6 and §217.9 became effective January 17, 2012.

### **Did you know....**

Safe Harbor is an internal process within nursing practice settings. Facility policies and procedures should identify that safe harbor is invoked with the supervisor who requested the conduct or assignment. There are forms that may be used for safe harbor on the Board of Nursing (BON) website that are designed to capture the required information. While you do not have to use the BON forms to invoke safe harbor, the request for safe harbor **must** be in writing. When you invoke safe harbor in good faith, then you have both employment and licensure protections.

## Maintaining Patient Confidentiality - Social Media Case Scenarios



In the October 2011 issue of the *Board of Nursing (BON) Bulletin* (pgs. 10-11), excerpts were included from the National Council of State Boards of Nursing (NCSBN) White Paper:

*A Nurse's Guide to Social Media.* In this issue of the *Bulletin*, case scenarios from various practice settings are provided to illustrate the importance of maintaining patient confidentiality and privacy at all times.

Below are scenarios in which nurses from three different practice settings violated protected health information laws. The nurses worked in long-term care, hospice, and home health. Readers are encouraged to consider their own social media practices in relation to these scenarios. The following cases do not involve nurses currently under investigation by the Texas BON.

### Long-Term Care

Sally, a nurse employed at a large long-term care facility, arrived at work one morning and found a strange email on her laptop. She could not tell the source of the email, only that it was sent during the previous nightshift. Attached to the email was a photo of what appeared to be an elderly female wearing a gown with an exposed backside bending over near her bed. Sally asked the other dayshift staff about the email/photo and some confirmed they had received the same photo on their office computers. Nobody knew anything about the source of the email or the identity of the woman, although the background appeared to be a resident's room at the facility. In an effort to find out whether any of the staff knew anything about the email, Sally forwarded it to the computers and cell phones of several staff members who said they had not received it. Some staff discussed the photo with an air of concern, but others were laughing about it as they found it amusing. Somebody on staff started an office betting pool to guess the identity of the resident. At least one staff member posted the photo on her blog.

Although no staff member had bothered to bring it to the attention of a supervisor, by midday, the director of nursing and facility management had become aware of the photo and began an investigation as they were very concerned about the patient's rights. The local media also became aware of the matter and law enforcement was called to investigate whether any crimes involving sexual exploitation had been committed. While the county prosecutor, after reviewing the police report, declined to prosecute, the story was heavily covered by local media and even made the national news. The facility's management placed several staff members on administrative leave while they looked into violations of facility rules that emphasize patient rights, dignity and protection.

Management reported the matter to the BON, which opened investigations to determine whether state or federal regulations against "exploitation of vulnerable adults" were violated. Although the originator of the photo was never discovered, nursing staff, including Sally, also faced potential liability for their



willingness to electronically share the photo within and outside the facility, thus exacerbating the patient privacy violations, while at the same time, failing to bring it to management's attention in accordance with facility policies and procedures. The patient in the photo was ultimately identified and her family threatened to sue the facility and all the staff involved. The BON's complaint is pending and this matter was referred to the agency that oversees long-term care facilities.

This scenario shows how important it is for nurses to carefully consider their actions. The nurses had a duty to immediately report the incident to their supervisor to protect patient privacy and maintain professionalism. Instead, the

situation escalated to involving the BON, the county prosecutor and even the national media. Since the patient was ultimately identified, the family was embarrassed and the organization faced possible legal consequences. The organization was also embarrassed because of the national media focus.

### Home Health

A BON received a complaint that a nurse had blogged on a local newspaper's online chat room. The complaint noted that the nurse bragged about taking care of her "little handicapper." Because they lived in a small town, the complainant could identify the nurse and the patient. The complainant stated that the nurse was violating "privacy laws" of the child and his family. It was also discovered that there appeared to be debate between the complainant and the nurse on the blog over local issues. These debates and disagreements resulted in the other blogger filing a complaint about the nurse.

A check of the newspaper website confirmed that the nurse appeared to write affectionately about the handicapped child for whom she provided care. In addition to making notes about her "little handicapper," there were comments about a wheelchair and the child's age. The comments were not meant to be offensive, but did provide personal information about the patient. There was no specific identifying information found on the blog about the patient, but if you knew the nurse, the patient or the patient's family, it would be possible to identify who was being discussed.

The board investigator contacted the nurse about the issue. The nurse admitted she is a frequent blogger on the local newspaper site; she explained that she does not have a television and blogging is what she does for entertainment. The investigator discussed that as a nurse, she must be careful not to provide any information about her home care patients in a public forum.

The BON sent a letter of warning to the nurse advising her that further evidence of the release of personal information about patients would result in disciplinary action.

This scenario illustrates that nurses need to be careful not to mention work issues in their private use of websites, including posting on blogs, discussion boards, etc. The site used by the nurse was not specifically associated with her like a personal blog is; nonetheless the nurse posted sufficient information to identify herself and the patient.



### Hospice

Jamie has been a nurse for 12 years, working in hospice for the last six years. One of Jamie's current patients, Maria, maintained a hospital-sponsored communication page to keep friends and family updated on her battle with cancer. Jamie periodically read Maria's postings, but had never left any online comments. One day, Maria posted about her depression and difficulty finding an effective combination of medications to relieve her pain without unbearable side effects. Jamie knew Maria had been struggling and wanted to provide support, so she wrote a comment in response to the post, stating, "I know the last week has been difficult. Hopefully the new happy pill will help, along with the increased dose of morphine. I will see you on Wednesday."

The site automatically listed the user's name with each comment. The next day, Jamie was shopping at the local grocery store when a friend stopped her and said, "I didn't know you were taking care of Maria. I saw your message to her on the communication page. I can tell you really care about her and I am glad she has you. She's an old family friend, you know. We've been praying for her but it doesn't look like a miracle is going to happen. How long do you think she has left?" Jamie was instantly horrified to realize her expression of concern on the

webpage had been an inappropriate disclosure. She thanked her friend for being concerned, but said she couldn't discuss Maria's condition.


She immediately went home and attempted to remove her comments, but that wasn't possible. Further, others could have copied and pasted the comments elsewhere.

At her next visit with Maria, Jamie explained what had happened and apologized for her actions. Maria accepted the apology, but asked Jamie not to post any further comments. Jamie self-reported to the BON and is awaiting the BON's decision.

This scenario emphasizes the importance for nurses to carefully consider the implications of posting any information about patients on any type of website. While this website was hospital sponsored, it was available to friends and family.

In some contexts it is appropriate for a nurse to communicate empathy and support for patients, but nurses should be cautious not to disclose private information, such as types of medications the patient is taking.

primary practice sites were all represented. The majority of the RNs, 39%, provide inpatient hospital care, and 45% of the respondents identified themselves as staff nurses. All primary specialty settings were represented, with the highest number, 15%, working in medical/surgical areas.

Only the significant findings of the survey are reported here. This includes a finding involving membership in professional organizations (American Nurses Association/Texas Nurses Association; National League for Nursing, Sigma Theta Tau, or clinical specialty). Those RNs indicating they had no organizational membership were spread across the age cohorts from 72% in the silent generation to 63% of the millennial generation.

Question 18 related to behaviors of the RN maintaining licensure and knowledge about the NPA. There were two significant variables that identified lack of in-depth knowledge. The first was knowledge of delegation. There was no distinction in knowledge between the

acute care environment and the independent living environment. The second area was knowledge of the Nurse Licensure Compact. Responses were evenly distributed between the four age cohorts, with 36% for the silent generation to 29% for the millennial generation.

Question 19 requested RNs to indicate their knowledge of state or federal laws and rules that impact nursing practice. Four variables were noted to be significant. These variables included Facility/Institutional Licensing and Certification Requirements; Client Abuse and Neglect; Pharmacy Laws; and Whistleblower Protections.

These aforementioned variables will be discussed in the published manuscript to be made available on the Board of Nursing website (see link information on page one). References will also be identified for RNs to gain knowledge to enhance their nursing practice in relationship to these specific variables.

**ROXANNE DENISE ANDERSON**  
**AKA: ROXANNE DENISE ANDERSON-BAILEY**

Roxanne Denise Anderson Bailey secured employment with a dialysis facility in Houston, Texas. On November 15, 2010, Roxanne Anderson misrepresented herself as a Board of Nephrology Examiners Nursing and Technology (BONENT) Certified Hemodialysis Technician and as a Graduate Nurse. She submitted a certificate from the the BONENT which turned out to be fraudulent and she also presented paperwork from the Board of Nursing, including a Pearson Vue Authorization to Test and a Certificate of Completion of the Nursing Jurisprudence exam. On November 15, 2010, she began working as a GN. When she failed to produce her temporary license to practice as a GN, the facility searched the Board website and could not verify a license. On December 15, 2010, the facility contacted the Board office and confirmed that there was no permit issued to Ms. Anderson and the Authorization to Test was issued to another individual. Roxanne Denise Anderson, aka Roxanne Denise Anderson-Bailey was terminated effective December 20, 2010. The case was referred to the Houston Police Department.

**YOUSRA ILTAF KHAN**

The Board received information that Yousra Iltaf Khan had obtained a license to practice nursing in Texas by fraud. On June 4, 2010, Yousra Iltaf Khan submitted an Application for Licensure by NCLEX-RN Examination to the Board which indicated that she graduated from Dutchess Community College. The Board has since received verification from Dutchess Community College, Poughkeepsie, New York that Yousra Iltaf Khan has never completed a nursing program and was not awarded an Associate Degree in Nursing as she indicated on the application. The case was referred to the Travis County District Attorney's Office.
