The mission of the Texas Board of Nursing is to protect and promote the welfare of the people of Texas by ensuring that each person holding a license as a nurse in the State of Texas is competent to practice safely. The Board fulfills its mission through the regulation of the practice of nursing and the approval of nursing education programs. This mission, derived from the Nursing Practice Act, supersedes the interest of any individual, the nursing profession, or any special interest group.

Nursing Bills Advance following the 2013 Regular Texas Legislative Session

Four bills amending the Nursing Practice Act were signed into law on June 14, 2013 by Governor Rick Perry.

Senate Bill (SB) 1058 by Jane Nelson adds new continuing education requirements related to nursing jurisprudence and ethics, as well as continuing education related to older adults or geriatric populations for nurses working in a practice area related to geriatric populations.

SB 1058: makes criminal background checks mandatory for students accepted for enrollment in a nursing education program and permits the Board of Nursing (BON or Board) to initiate declaratory orders for eligibility proceedings based on positive criminal background checks; makes permanent

the Board's current pilot authority to impose deferred disciplinary action; clarifies that action may be taken against a nurse's license based on action taken by a division of the United States Military; authorizes the BON, in conjunction with a disciplinary action, to require a nurse to abstain from use of alcohol and drugs and submit to random drug testing; provides for limited non-disclosure of disciplinary proceedings that result in a Board order requiring the nurse to participate in a Board-approved peer assistance program to address a problem that the nurse is experiencing with mental illness or chemical dependency; as well as making other changes relating to disciplinary action taken by the Board.

SB 406 by Jane Nelson eliminates the requirement for on-site physician supervision and increases the number of Advanced Practice Registered Nurses a physician can supervise from four to seven. Additionally, it allows physicians to delegate authority to prescribe Schedule II controlled substances in hospitals and hospice settings. The bill requires periodic face-to-face meetings between APRNs and the delegating physician.

SB 743 by Jane Nelson requires the BON to suspend a nurse's license or refuse to issue a license to an applicant on proof that the nurse or applicant has been initially convicted of an offense involving a violation of certain court orders or conditions of bond under Section 25.07, 25.071, or 25.072, Penal Code, punished as a felony, or other offenses.

House Bill 581, authored by Donna Howard, authorizes a nurse employed by a hospital operated by or on behalf of a state or local entity to sue the

governmental entity to recover limited damages for certain retaliatory actions taken against the nurse for fulfilling obligations as a licensed nurse practicing under Texas law; and specifies that sovereign immunity of the state or local governmental entity from suit and from liability is waived for the limited purpose of allowing the nurse to maintain a lawsuit in state court to obtain such relief.

Nursys is the only national database for verification of nurse licensure, discipline, and practice privileges for registered nurses (RNs) and licensed practical/vocational nurses (LPN/VNs). The e-Notify program automatically delivers licensure and publicly available discipline data directly to employers as the data is entered into the Nursys database by United States boards of nursing (BONs) through frequent, secured updates.

Law and Regulation Online Study Results Posted on BON Website

The Board of Nursing (BON) has posted the final report on the *Professional Practice Accountability: Law and Regulation* online survey on the BON website under BON News (www.bon.texas.gov/about/news.html). The purposes of this survey were to: (1) obtain demographic information; and (2) determine RNs' depth of knowledge of the laws and regulations affecting RN practice in Texas. The University of Texas Health Science Center at Houston's Committee on Protection of Human Subjects administratively approved the survey, which was hosted on Zoomerang Premium beginning in July 2011. Interim Approval and Prescriptive Authority Paper Letters for APRNs Discontinued in September 2013

In order to expedite the licensing of Advanced Practice Registered Nurses (APRNs), the Texas Board of Nursing (BON) will discontinue the mailing of approval letters for Interim Approval and Prescriptive Authority beginning September 1, 2013. Interim approval and prescriptive authority can be verified on the Board's website twenty-four hours a day, seven days a week. The BON is the primary source for this type of verification.

APRNs and their employers may choose to print and retain a copy of interim approval and prescriptive authority approval directly from the Board's website (www.bon.texas.gov). To access this information, click on **Verification and Licensing**, then **Advanced Practice Recognition for Registered Nurses**. Nurses with a Texas RN license may use their Texas RN License number to access interim approval (temporary authorization to practice) or prescriptive authority approval. Nurses practicing in Texas on a multi-state registration should use the last four digits of their social security number and their birthdate to verify interim approval (temporary authorization to practice) or prescriptive authority approval. Texas RNs, receiving advanced practice licensure, will still receive a wall certificate in the mail when full licensure is granted to practice as APRNs.

Verification of interim approval and prescriptive authority approval can also be completed by phone, Monday through Friday, 8:00 am to 5:00 pm, Central Standard Time, by contacting the Customer Service Department of the BON at (512) 305-7400. Advisory Committee Update

Advanced Practice Nursing Advisory Committee

The Advanced Practice Nursing Advisory Committee (APNAC) met on May 31, 2013 in Austin. Committee members discussed recommendations for amendments to Rule 222 as a result of passage of Senate Bill 406 authored by Senator Nelson. These proposed revisions address changes related to advanced practice registered nurses with prescriptive authority. The committee's recommendations regarding Rule 222 will be submitted for the Board's consideration in July 2013. APNAC members also continued discussions on Rule 221 revisions and will resume these discussions at the next meeting scheduled for July 1, 2013.

Summary of Actions

A regular meeting of the Board of Nursing was held April 18-19, 2013, in Austin. The following is a summary of Board actions taken during this meeting.



On May 17, 2013, the Board proposed amendments to 22 Tex. Admin. Code (TAC) sections 211.4 (relating to Officers), 213.27 (relating to Good Professional Character), 213.28 (relating to Licensure of Persons with Criminal Offenses), 213.29 (relating to Criteria and Procedure Regarding Intemperate Use and Lack of Fitness in Eligibility and Disciplinary Matters), 213.30 (relating to Declaratory Order of Eligibility for Licensure), 213.33 (relating to Factors Considered for Imposition of Penalties/Sanctions), and 217.14 (relating to Registered Nurses Performing Radiologic Procedures). The comment period ended on June 17, 2013. No comments were received.

The amendments to 22 TAC 211.4 specifies that the term of the Vice President will be a two-year term and that Board elections will be held biennially, based upon the calendar year.

The amendments to 22 TAC 217.14 update outdated references in the rule and correct grammatical/typographical errors.

The amendments to 213.27 - 213.30 and 213.33 affect the Board's Disciplinary Guidelines for Criminal Conduct. The Board issued a charge to the Eligibility and Disciplinary Advisory Committee to review and make recommendations regarding the Guidelines. The Committee's recommended changes to the Guidelines, along with minor editorial/typographical changes identified by Board Staff, were presented to the Board at its April 2013 meeting. The Board voted to adopt the Guidelines, as amended.

While many of the changes to the Guidelines are editorial and organizational in nature, some of the changes are more substantive. First, thirty-five new criminal offenses have been added to the Guide-

lines. These offenses include various felonies and misdemeanors, as well as crimes that have been specifically identified by the Texas Legislature in the Occupations Code §301.4535 as affecting nursing licensure. In addition to including these additional crimes in the Guidelines, corresponding sanction recommendations and explanatory rationale has been included as well. The Guidelines also explain how each of the additional offenses are related to the practice of nursing. Finally, the Guidelines indicate when a particular evaluation may be required and/or requested by the Board.

Amended 22 TAC 211.4, 217.14. 213.27 - 213.30 will become effective July 10, 2013 and 213.33 will become effective on July 11, 2013.

Academic Progression in Nursing: A Response to the Future of Nursing

Nursing leaders, regulators and legislators are becoming increasingly concerned about the barriers to academic progression in Texas. Texas was one of nine states privileged to receive the Academic Progression in Nursing (APIN) grant from the Robert Wood Johnson Foundation through the Tri-Council. The APIN project aims to address the challenges of academic progression to create a more educated and diverse Texas nursing workforce, important to meet current and future health care needs.

The Texas Nurses Foundation, Texas Action Coalition, and project directors, Dr. Kathryn Tart, from the University of Houston – Victoria, Dr. Susy Sportsman, and Dr. Helen Reid, from Trinity Valley Community College, are implementing a multi-focused statewide plan with the ultimate goal of assisting RN to BSN programs to increase by 230% the number of associate degree prepared nurses graduating each year, from 1,826 in AY 2010-2011 to 4,200 in AY2013-2014..

Education, practice and diversity form the cornerstones of the project. It will take many different strategies to meet the Institute of Medicine (IOM) recommendation of 80% of RNs with BSNs by 2020. One strategy is the creation of the Consortium for Advancing Baccalaureate Nursing Education in Texas (CABNET), a unique partnership between universities and community colleges. APIN's strategies focus on the community college student who wants to be a nurse. These students will be encouraged to take the general education courses for both the ADN and RN-

to-BSN levels so that when they complete the general education courses, the two-year ADN program and pass NCLEX-RN®, they will need to complete only the last year of upper division BSN nursing courses. The CABNET pathway standardizes the general education courses for a 120 semester credit hour ADN-BSN degree. This 1+2+1 pathway will result in a higher percentage of ADN graduates continuing their nursing education and increasing their employability.

Several RN-to-BSN and MSN faculty are developing concept-based courses that will complement the ADN level concept-based curriculum being implemented in the fall of 2013. Through surveys and focus groups, practice partners will contribute what qualities the "Nurse of the Future" should possess. To assist with faculty development on this new approach to nursing education, the APIN grant is hosting four webinars led by national leaders to teach nursing faculty about teaching in a concept-based curriculum. The archived webinars can be found on the APIN website at www.texasapin.org.

Dr. Josefina Lujan, from the Texas Tech University Health Sciences Center Gayle Greve Hunt School of Nursing in El Paso, is leading a mentorship program that assists RNs representing ethnic and gender diversity to obtain their BSN. To date, Diversity Champions from all eight Team Texas regions are recruiting mentors, and many regions have secured their students to mentor. Dr. Terry Kirk, from the University of Houston – Victoria, serving in dual roles as a member of the diversity advisory

committee and Diversity Champion has plans for starting a chapter of the Men in Nursing Association in the greater Houston area. Champions plan to hold information sessions at Hispanic serving community colleges and local minority nursing associations to encourage current ADN graduates to return for their BSN.

FREQUENTLY ASKED QUESTIONS - RN Delegation in the Independent Living Environment

Question: I recently learned that the list of tasks that a RN may designate as health maintenance activities (HMAs) has been expanded. Is that true?

Answer: Yes, the Board approved expanding this list during the January 2013 meeting, according to their authority under Rule 225.4(8) (E).

RNs in independent living environments such as home and community-based settings or school health must utilize the rules in Chapter 225, *RN Delegation to Unlicensed Personnel and Tasks Not Requiring Delegation in Independent Living Environments for Clients with Stable and Predictable Conditions*, when making decisions that pertain to delegation. The RN, depending on the assessment of the client and the delegation criteria, may decide to: designate a task a HMA that does not require delegation; delegate a task to an unlicensed person; or have a nurse perform the task.

HMA's are defined as "tasks that enable the client to remain in an independent living environment and that go beyond activities of daily living (ADLs) because of the higher skill level required to perform", [Board Rule 225.4(8)]. The Board believes that expanding the list of HMAs will foster a client's independence and further supports a client or the client's responsible adult (CRA) who is able to train and supervise unlicensed personnel in the performance of a HMA, thus enabling the client to remain in the least restrictive environment possible. For a complete list of tasks that can be designated as HMAs please refer to Board Rule 225.4(8) (A-E). The additional tasks that may be designated as HMAs are:

- Topically applied medications
- Insulin administration subcutaneously, nasally, or via an insulin pump



Because all nurses are required to promote a safe environment for their clients and others [Board Rule 217.11(1)(B)], the RN must always consider what is safest for the client when making decisions to designate a task a HMA that does not require delegation. Nurses are reminded to document their decisions concerning delegation in the client's record.

Question: Are there any medications or procedures that may be delegated in an emergency situation in independent living environments such as in home health or school health?

Answer: In January 2013, the Board approved a list of life-sustaining medications and treatments that a RN may delegate in emergency situations for clients residing in independent living environments, provided the RN has an order to administer or perform the treatment and the client has received a diagnosis that required a prescription for:

- Glucagon injections for treatment of severe hypoglycemia in unconscious clients or clients who are unable to swallow oral glucose
 - Epinephrine injections from a single-dose pre-filled automatic injection device for severe allergic anaphylactic reactions
 - Diazepam rectal gel in a pre-filled syringe for episodes of increased seizure activity
 - Nitroglycerin tablet(s) administered sublingually for the acute relief of an attack of angina pectoris
 - Use of a hand held magnet to activate a vagus nerve stimulator to prevent or control seizure activity
 - Metered dose inhalers or nebulizer treatments for the relief of acute respiratory symptoms
- Noninvasive ventilation (NIV) such as continuous positive airway pressure (CPAP) and bi-level positive airway pressure (BiPAP) therapy
 - Routine administration of a prescribed dose of oxygen
 - Unit dose medication administration by way of inhalation (MDIs) including medications administered as nebulizer treatments for prophylaxis and/or maintenance

- Oxygen administration for the relief of acute respiratory symptoms

Planning for emergencies in independent living environments requires the RN to utilize both Chapter 224, *Delegation of Nursing Tasks by Registered Professional Nurses to Unlicensed Personnel for Clients with Acute Conditions or in Acute Care Environments*, and Chapter 225. RNs must use their nursing judgment to decide when it is safe and appropriate to delegate life-sustaining medications and treatments to unlicensed personnel in independent living environments such as community-based settings, client homes or schools.

While all the delegation criteria are important in Board Rule 224.6, the RN must take into consideration how the supervisory standards will be met as delegation decisions are made. The RN is required to provide adequate supervision while an unlicensed person is performing a task, particularly in emergency situations. The RN must consider his or her geographical distance and the time it takes to reach a client that is experiencing



an emergency in order to direct unlicensed personnel when to notify the Emergency Medical System (EMS). RNs are also responsible for timely follow-up, which may include a face-to-face assessment depending on the emergency situation and the RN's location to the individual. Delegation decisions and instructions to unlicensed personnel should be documented in the client's record.

TPAPN Advocates: Assisting Nurses in their Darkest – and Brightest Hours

... sometimes our ordinary labor, administered in the right dose at the right time, can provide extraordinary mercy. And in our world, our colleagues never have to fear facing their darkest hours alone.¹

The Texas Peer Assistance Program for Nurses (TPAPN) is a private, nonprofit program of the Texas Nurses Foundation that provides approved peer assistance services for the Texas Board of Nursing (BON). TPAPN's mission is to offer nurses life-renewing opportunities for recovery from substance use disorders and certain psychiatric disorders, and to protect the public by promoting professional accountability and returning nurses to safe practice. Referrals may be made directly to TPAPN; however, if a practice violation is suspected, the report **must** be made to the BON.

Volunteer advocates for TPAPN provide encouragement and support to participating nurses that are working hard to recover. The following excerpt from an email exchange between a participant and her TPAPN Case Manager attests to the presence and insight created by an advocate.

Dear Ginger, ...When I discovered I couldn't work, my alcoholic mind went straight to the worst case scenario.....i.e. there would be no presents under the tree for my children; I would lose my job; I wouldn't be able to make my house payment and would have to move back in with my family.... My advocate gave me hope....

Sometimes it may seem that those who care the most for others receive the least amount of care from their colleagues. However, TPAPN is one avenue for nurses to change that value system. There are TPAPN advocates who have successfully completed the TPAPN program and continue to maintain their recovery. Approximately 50% of all advocates simply have a desire to help nurses going through TPAPN. Advocates are motivated to volunteer for personal reasons that stem from past family issues or prior experiences with colleagues, i.e., "the work family." The desire to advocate may also arise from one's spiritual center that is fulfilled through giving to others. In the process of giving to others, advocates learn first-hand from participants about TPAPN and recovery

from substance use disorders and certain psychiatric disorders. In the final analysis however, almost every TPAPN advocate will tell you that having the opportunity to witness an individual's recovery is sufficient reward.

On November 8 and 9, 2013, in Austin, TPAPN will be providing a free advocate training for nurses whose advocate applications have been approved for attendance. Other interested persons may register and pay a fee to attend. Marie Manthey, RAN, MNA, RFCN, PhD (hon.), will be the featured guest speaker and nursing contact hours will be awarded. It is important to note that nurses interested in becoming TPAPN advocates do not have to be graduates of the program. If the potential TPAPN advocate is a graduate of

the TPAPN program, then TPAPN requires at least two years of good recovery or solid sobriety to be eligible.
