Nursing Fatigue: Avoiding Patient Safety Risks

National patient safety initiatives have been gaining momentum since the Institute of Medicine's first report *To Err is Human* in 1999. Mental, physical, and total fatigues are factors that have been linked in the literature to performance decrements, placing patient safety at risk. Fatigue not only impacts the patient population, but can impact the quality of life of the nurse and can impact the employer, resulting in increases in health care and workers' compensation costs, early disability,

recruitment and training costs, and legal fees associated with practice errors.¹

The effects of inadequate sleep on clinical decision-making place the public at risk. A 2014 systematic review of the literature reveals a strong relationship between fatigue resulting from long nursing work hours with adverse patient outcomes. Fatigued nurses have a higher incidence of flawed decision-making, leading to practice breakdowns that impact

patient outcomes. Furthermore, nurses who experience impairments due to fatigue, loss of sleep, and inability to recover between shifts are more likely than unimpaired nurses to report decision regret after a practice breakdown occurred. In many of today's health care settings, nurses are challenged to balance and manage multiple competing tasks associated with job expectations and patient care. As a result, it is no wonder nurses experience high rates

Task Force to Study Implications of Growth in Nursing Education Programs in Texas

produced by the Task Force, Promoting Optimal Clinical Instruction, by Janice I. Hooper, PhD, RN, FRE, BON Nursing Consultant for Education; Presentation of Exemplars of Clinical Instruction by Four Nursing Faculty; Nurse Educator Panel on Excellence in Clinical Instruction; Student Panel on Excellence in Clinical Instruction; and the Clinical Partner Panel on Excellence in Clinical Instruction. Future plans for the Task Force include dissemination of the group's research findings through publication in national nursing journals.

Montana Becomes 25th State to Join the Nurse Licensure Compact

The National Council of State Boards of Nursing and the Nurse Licensure Compact Administrators (NLCA) announced that Montana has passed legislation to join the Nurse Licensure Compact (NLC), which was signed into law by Governor Steve Bullock. The state will now begin the rulemaking process to work toward implementation on October 1, 2015. Currently, 24 other states have enacted the legislation allowing for participation in the NLC, including: Arizona, Arkansas, Colorado, Delaware, Idaho, Iowa, Kentucky, Maine, Maryland, Mississippi, Missouri, Nebraska, New Hampshire, New Mexico, North Carolina, North Dakota, Rhode Island, South Carolina, South Dakota, Tennessee, Texas, Utah, Virginia, and Wisconsin.

Operationally, the NLC is administered by the NLCA, which is made up of the participating state-designated NLC administrators. Founded March 15, 1978, as an independent not-for-profit organization, NCSBN was created to lessen the burdens of state governments and bring together boards of nursing to act and counsel together on matters of common interest.

Summary of Actions

A regular meeting of the Board of Nursing was held January 22-23, 2015, in Austin. The following is a summary of Board actions taken during this meeting.



In the January 23, 2015 issue of the Texas Register, the Texas Board of Nursing (BON) published as adopted amendments to §223.1, concerning *Fees*. The amendments were proposed under the authority of the Occupations Code §301.151 and §301.155 and are necessary to comply with budgetary requirements established by the Texas Legislature. The amendments reduce each current level of licensure renewal by \$10, thereby making the new renewal fee for a vocational nurse license \$45; the renewal fee for a registered nurse license \$60; and the renewal fee for an advanced practice registered nurse license \$50. Amended §223.1 became effective January 11, 2015.

Also, in the January 23, 2015 issue of the Texas Register, the Texas BON published as adopted amendments to Chapter 224. *Delegation of Nursing Tasks by Registered Professional Nurses to Unlicensed Personnel for Clients with Acute Conditions or in Acute Care Environments*.

The BON adopts amendments to Chapter 224, §§224.1 - 224.3 and §§224.5 - 224.11 without changes to the proposed text published in the December 5, 2014 issue of the Texas Register (39 TexReg 9451).

The amendments to the chapter correct outdated references to the "Board of Nurse Examiners" (BNE) and legal citations; clarify "continuously

provided" to include correctional health settings; provide guidance to Advanced Practice Registered Nurses (APRN) in the application of the delegation rules to delegate nursing tasks to unlicensed personnel; clarify responsibilities of the Chief Nursing Officer (CNO) and other Registered Nurse (RN) responsibilities when supervising tasks delegated to unlicensed personnel or when delegated by another practitioner; and allows RNs to delegate the collection of capillary blood and urine tests to unlicensed personnel for more than just "sugar and hematests."

Effective date for amendments to Chapter 224 is January 27, 2015.

of fatigue. Factors that contribute to the prevalence and intensity of work-related nursing fatigue include individual lifestyle as well as organizational culture and policies surrounding attendance, work-life balance, and self-care. Preventing work-related fatigue requires a multifaceted approach involving the individual and the organization in which the nurse works.^{2, 3, 4}

The Board has long held individual nurses accountable for making prudent judgments with regard to patient safety when accepting an assignment. The prudence and accountability of the nurse is especially significant in the context of fatigue. The standards of nursing practice require each nurse to provide for patient safety and to accept only those assignments that are commensurate with the nurse's level of education, experience, knowledge, and physical and emotional abilities [22 TAC §217.11 (1) (B) and (T)]. The individual nurse is accountable to

evaluate and assess his/her fatigue and physical condition to the extent that it could place the public at risk. A nurse has a duty to always advocate for patient safety, including any nursing action necessary to comply with the standards of practice.

At the same time, the Board provides avenues for nurses to refuse to engage in an act relating to patient care that would constitute a violation of the Nursing Practice Act (NPA) or Board Rules [Tex. Occ. Code 301.352 and 22 TAC §217.20]. Safe Harbor and the Whistleblower Protections, outlined in 22 TAC §217.20, describe the processes that protect nurses from employer retaliation, suspension, termination, discipline, discrimination, and licensure sanction when a nurse makes a good faith request for peer review of an assignment which the nurse believes would violate the NPA or Board Rules. These processes are equally available to the fatigued nurse. The Case Study in Table 1 highlights the importance of the

nurse's role in advocating for patient safety. In the case study, the nurse accepted accountability for her physical condition and acted prudently in collaborating with her supervisor to protect her license while advocating for her patients' safety.

Registered nurses are responsible for working collaboratively with supervisors and colleagues to ensure patient safety. In addition, registered nurses are responsible for implementing evidence-based fatigue countermeasures and strategies to reduce the risks of fatigue.⁵ In 2014, the American Nurses Association updated the position statement on fatigue, addressing safety promotion and workplace collaboration in managing nurse fatigue. Table 2 outlines eleven evidence-based recommendations and strategies for managing fatigue that could impact practice.⁵

Nurses are accountable to the public to ensure fitness for duty. Fatigue

Updated Position Statements Adopted at January Board Meeting

Board position statements do not have the force of law, but are a means of providing direction to nurses on issues of concern to the Board relevant to protection of the public. Board position statements are reviewed annually for relevance and accuracy to current practice, the Nursing Practice Act, and Board rules. The position statements that were changed at the January Board meeting are detailed below.

Position Statement 15.3, LVNs Engaging in Intravenous Therapy, Venipuncture, or PICC Lines, offers guidance to LVNs, RNs, and employers related to midline catheters. This additional information was prompted by e-mail inquiries related to midline catheters and aligns with the current position of the Board.

Position Statement 15.4, Educational Mobility, describes current options for educational mobility for military personnel and veterans.

Position Statement 15.26, Simulation in Prelicensure Nursing Education, has existed on the Board's website as both a position statement and a guideline. The guideline was revised based on research and to provide guidance to nursing education programs. The position statement has been eliminated to decrease any confusion that might result from the existence of two separate documents. The newly revised and approved guideline on the website in *Education*, then *Education Guidelines*, under the heading *Clinical Learning Experiences* and is listed as **3.8.6.a, Simulation in Pre-licensure Nursing Education**.

There were a few position statements with very minor changes. These were Position Statement 15.2, The Role of the Licensed Vocational Nurse in the Pronouncement of Death, where the letter "s" was added to the word "sign"; Position Statement 15.6, Board Rules Associated with Alleged Patient "Abandonment," where a reference was deleted related to current lack of relevance; and Position Statement 15.12, Use of American Psychiatric Association Diagnoses by LVNs, RNs, or APRNs, was edited to correctly reference the book: *Diagnostic and Statistical Manual of Mental Disorders or DSM-5*.

The **BON position statements** are accessible on the website in *Practice*. The position statements address many different topics and practice settings.

impacts a nurse's ability to physically and mentally respond, placing the public at risk for practice breakdown. Through careful self-assessment, patient safety advocacy and self-care measures, nurses can improve care outcomes while ensuring compliance with the rules and regulation surrounding the standards of nursing practice.

Table 1: Case Study

Sally works in a busy, 36 bed telemetry unit. Over the last week, staffing has been short. Sally, a strong nurse and team-player, volunteers to pick up extra shifts to help cover the unit.

Sally has worked the last 5 days in a row, 12-hour shifts each day. She notices that she is having a hard time focusing and concentrating on the tasks before her. She also notices that she feels slightly dizzy and can't seem to get motivated. Sally stops what she is doing and inventories her symptoms. She comes to the conclusion that because she is so mentally and physically fatigued, she poses a risk to her patients.

Sally calls her supervisor and explains the risks to patient safety. After she and her supervisor review Board Rules §217.11 (1) (B) and (T) and §217.20, Sally decides to invoke Safe Harbor to protect her license. Her supervisor asks Sally to continue caring for her assigned patients while she looks for a suitable replacement to relieve Sally.

Table 2: ANA Recommendations for Nurses

1. Sleep 7–9 hours within a 24-hour period and consider implementing the following strategies to improve quality of sleep:
 - a. Adjust the sleep environment so it is conducive to sleep.
 - b. Remove distractions, bright lights, and electronics from your sleep environment.
2. Rest before a shift in order to avoid coming to work fatigued.
3. Be aware of side effects of over-the-counter and prescription medications because they may impair alertness and performance.
4. Improve overall personal health and wellness through stress management, nutrition, and frequent exercise.
5. Use related benefits and services offered by employers, such as wellness programs, education and training sessions, worksite fitness centers, and designated rest areas.
6. Take scheduled meals and breaks during the work shift.
7. Use naps (in accordance with workplace policies).
8. Follow established policies, and use existing reporting systems to provide information about accidents, errors, and near misses.
9. Follow steps to ensure safety while driving:
 - a. Recognize the warning signs of drowsy driving.
 - b. Use naps, caffeine, or both as appropriate in order to be alert enough to drive.
 - c. Avoid driving after even small amounts of alcohol when sleep deprived.
 - d. Importantly, note that the actions people often take when struggling with drowsy driving (such as putting windows down, pinching themselves, turning up the radio) do not work.
10. Consider the length of a commute prior to applying for employment.
11. Prior to accepting a position, consider the employer's demonstrated commitment to establishing a culture of safety and to reducing occupational hazards, including nurse fatigue.



Infectious Diseases and Your Duty as a Nurse



Infectious diseases are a challenge that nurses on the frontlines face every day. The Centers for Disease Control and Prevention provides recommended guidelines and the latest information for management of both emerging and recurrent infectious diseases that threaten our population. The Texas Board of Nursing (Board or BON) encourages all nurses to become familiar with these disease processes based on evidence and research from reputable sources. Nurses are an integral part of safe patient care and are advocates for patient safety.

In order to advocate for patients, nurses must become informed and comply with the recommended hand washing, personal protective equipment and follow other appropriate guidelines to prevent exposure to and the potential spread of infectious pathogens and communicable conditions [§217.11(1) (O)]. Nurses have opportunities to provide education and guidance to patients, families, communities, and other members of the healthcare team.

The BON regulates the practice of nursing and cannot direct a healthcare facility on infectious disease preparedness or response; nor can the BON make determinations on whether healthcare facilities are prepared. These types of questions should be directed to the Texas Department of State Health Services for hospital settings or to the Texas Department of Aging and Disability Services for long-term care or home health settings.

Board Rule 217.11 *Standards of Nursing Practice* is the heart of nursing practice. Each nurse should obtain instruction and supervision when implementing nursing procedures [§217.11(1) (G)] and make reasonable efforts to obtain orientation and training to develop or maintain competency when encountering new or unfamiliar situations [§217.11(1)(H)]. Each nurse is responsible for his or her own continuing competency in nursing

practice [§217.11(1) (R)].

Additionally, nurses should remember to protect the client's right to privacy by safeguarding protected health information as they provide, without discrimination, nursing services regardless of the age, disability, economic status, gender, national origin, race, religion, health problems, or sexual orientation of the client served [§217.11(1) (E) and (L)].

The standards of nursing practice further require nurses to accept only those assignments which they are competent to carry out safely [§217.11(1) (B) and (T)]. Information about Safe Harbor may be helpful to nurses as they decide whether they are competent to care for patients who may have infectious diseases. In addition, the *Six-Step Decision-Making Model for Determining Nursing Scope of Practice* will help nurses make decisions about safe assignments. Refusing to engage in an assignment related to standards (1)(B) and (1)(T) are sometimes the basis for invoking Safe Harbor. It's important to remember that the Safe Harbor process is collaborative in nature and focuses on problem-solving. The Nursing Practice Act (NPA) Section 301.352 permits a nurse to refuse to engage in conduct that may jeopardize the safety of a patient or is unlawful.

When considering whether refusing an assignment and invoking Safe Harbor is an appropriate action, Board staff recommends that nurses review Position Statement 15.6, Board Rules Associated with Alleged Patient Abandonment. This position statement provides the Board's opinion on the distinction between a nurse leaving an employment setting versus a nurse violating a duty to a patient through leaving an assignment. The first is an employment issue and the second is potentially a licensure issue.

SHEILA MARIE EYRE VINCENT a.k.a. Sheila Marie Eyre

Sheila Marie Eyre Vincent had been employed as a Registered Nurse with a clinic in College Station Texas, since 2006. On January 16, 2015, the clinic staff found that the license number Ms. Vincent was using belonged to another licensee. Ms. Vincent was placed on administrative leave on January 19, 2015, pending investigation. On January 21, 2015, Ms. Vincent emailed the clinic a resignation. Sheila Marie Eyre Vincent is not licensed to practice professional nursing in the State of Texas and she had presented forged documents to secure the position of RN. She was using a license number belonging to a licensee who resides in the Dallas area. Sheila Marie Eyre Vincent was arrested January 26, 2015 and then later turned herself in to the Brazos County Sheriff's Department. She was charged with a third-degree felony forgery of a government instrument and fraudulent use of identifying information, a state jail felony. The case is pending in Brazos County.



KIMBERLY ANN JOHNSON (SFAKIANOS) a.k.a. Kimberly Ann Johnson

On May 13, 2014, the Board revoked the Privilege to Practice (PTP) from Mississippi belonging to Kimberly Ann Johnson (Sfakianos). On August 8, 2014, Kimberly Ann Johnson (Sfakianos) applied for employment with a home health agency in McKinney, Texas. Respondent provided a license number belonging to another licensee with a similar name, but different social security number who resides in Houston, Texas. Kimberly Ann Johnson (Sfakianos) was hired and she began working for the agency on August 11, 2014, conducting home health visits for patients. On September 2, 2014, the agency received a phone call reporting that Respondent had her license (PTP) revoked. The agency contacted the Board and verified that the license number provided by Respondent belonged to a different licensee. Respondent was terminated from employment. The case was referred to the McKinney Police Department.



Statistical Information: Notice of Disciplinary Action

The 558 disciplinary actions reported in this edition of the *Bulletin* represent only 0.153% of all nurses who are currently licensed to practice in the State of Texas. For the statistical reporting period ending on February 2015, 99.43% of Registered Nurses and 98.77% of Licensed Vocational Nurses were without recent discipline according to the Board records.
