The mission of the Texas Board of Nursing is to protect and promote the welfare of the people of Texas by ensuring that each person holding a license as a nurse in the State of Texas is competent to practice safely. The Board fulfills its mission through the regulation of the practice of nursing and the approval of nursing education programs. This mission, derived from the Nursing Practice Act, supersedes the interest of any individual, the nursing profession, or any special interest group.

Changes to Controlled Substances Registration and Prescription Monitoring Program Coming September 1, 2016

Senate Bill (SB) 195 (84th Legislative Session) made changes to the process by which health care providers obtain authority to prescribe controlled substances. Under current law, advanced practice registered nurses (APRNs) with prescriptive authority who have been delegated the authority to prescribe controlled substances by the delegating physician are required to register with the Texas Department of Public Safety (DPS) and the US Drug Enforcement Administration (DEA) before they can prescribe controlled substances. On September 1, 2016, the law will change to eliminate the requirement for registration with the DPS. All DPS registrations will expire on August 31, 2016. DEA registration will still be required for APRNs who prescribe controlled substances in any schedule.

Another change that will take effect as a result of the passage of SB 195 is that the prescription monitoring program, currently known as Prescription Access in Texas, will move from its current location with the DPS to the Texas State Board of Pharmacy. Notifications regarding the change will be sent to current Prescription Access in Texas users reminding them of the change. The new prescription monitoring program is intended to be more user friendly, making it easier for providers to review prescription profiles. SB 195 also provides authorization for Texas to participate in a national system allowing providers to obtain prescription history information from other states where their patients may fill prescriptions. This will help APRNs more easily identify individuals who may be seeking prescriptions for non-therapeutic purposes.

The new prescription monitoring program will be available on September 1, 2016. Users will need to register before they will be able to access the new program, even if they are registered users of the Prescription Access in Texas program. As additional information regarding the new program becomes available, this information will be shared on the Texas Board of Nursing's website. Please check the website frequently for the latest information.

Transportation Safety and the Effects of Medication and Health Conditions

Nurses have a duty to keep patients safe [Rule 217.11(1)(B)], and that duty includes helping patients understand how their medications and medical conditions may influence their ability to perform various activities in and outside of the health care environment. Research from the National Transportation Safety Board (NTSB) related to pilots demonstrates the importance of discussions between health care providers and their patients about the potential risks that drugs and medical and mental health conditions can create when patients are operating a vehicle in any mode of transportation. It is important for nurses to remember that even over-the-counter medications, such as diphenhydramine or non-steroidal anti-inflammatory drugs, can cause side effects, such as drowsiness, that can affect thought processes and reaction time. Likewise, various health conditions can have an effect on a patient's ability to safely operate a vehicle. It is important to remember that the effects of medical

conditions and medications can affect the patient's personal safety, as well as the safety of those around them, when the patient is operating a vehicle in any mode of transportation, and the patient may be unaware of these effects.

Nurses play a key role in this important public health and safety issue. Nurses at all levels of licensure have a duty to educate their patients about the effects of medications and medical conditions and the importance of exercising caution when operating vehicles of any type [Rule 217.11(1)(F) and (1)(P)]. This helps nurses to promote patient safety for their patients and others who may come in contact with those patients [Rule 217.11(1)(B)]. Nurses must be sure to document their teaching regarding these important aspects of patient care [Rule 217.11(1)(D)]. When appropriate, the nurse may also educate the patient's significant other, family members, or caretakers regarding these concerns. The

New Licensing System coming this Fall!

The Texas Board of Nursing (BON) is currently working with the National Council of State Boards of Nursing on a new licensing system named the Optimal Regulatory Board System (ORBS), which will allow the BON to transition to completely paperless processes. Upon launching the system, each nurse will be required to access a portal from the BON website and create an account. Every nurse will be required to have a current email account. Since most applicants and licensees use the current online system, this should be a smooth transition. The BON will provide thorough instructions to all licensees in the next *BON Bulletin*.

Claudia Ochoa Esquivel

Claudia Ochoa Esquivel remained employed and practiced as a Licensed Vocational Nurse with a primary care clinic in Midland, Texas, between August 29, 2015, and October 14, 2015, after having previously voluntarily surrendered her license on August 28, 2015. Ms. Esquivel's employment was terminated after her employer verified her license using the Board's website and found that her license had been in surrendered status since August 28, 2015. The case has been referred to the Midland County District Attorney's Office.

Tammie D. Hailey

a.k.a. Tami Hailey; a.k.a. Tammie Phelps; a.k.a. Tammie Phelps Hailey

Tammie D. Hailey secured employment and practiced as a Licensed Vocational Nurse with a home health agency in Richardson, Texas, between December 7, 2015 and December 10, 2015. When a patient decided to transfer care to a different home health agency, Ms. Hailey submitted an application for employment with the new home health agency, who then discovered Ms. Hailey was not licensed to practice vocational nursing in the State of Texas. This case has been referred to the Cass County District Attorney's Office.



Juan Manuel Perez

Juan Manuel Perez secured employment and practiced as a Licensed Vocational Nurse at a local hospital in Harlingen, Texas, between June 2014 and November 2015 by using the license number belonging to another nurse with the same name. In addition, Mr. Perez presented the facility with a copy of a certificate showing that he had completed an educational program in vocational nursing from an accredited university; however, when the facility tried to verify the certificate with the university's registrar, the registrar indicated there was no record of Juan Manuel Perez completing a vocational nursing program. The facility terminated the employment of Juan Manuel Perez. The case has been referred to the Cameron County District Attorney's Office.



Topangelia Shaw

Topangelia Shaw gained employment and practiced as a Registered Nurse with a home health agency in Dallas, Texas, between March 2, 2015 through July 16, 2015, and with a home health agency in Fort Worth, Texas, between April 14, 2015 and June 26, 2015, using a registered nurse license number belonging to a nurse with a completely different name. When asked for additional information in order to verify her license, Ms. Shaw provided the name of a different nurse whose name was similar to Topangelia Shaw. Ms. Shaw does not hold a license to practice professional nursing in the State of Texas. The cases have been referred to the Dallas District Attorney's Office and to the Tarrant County District Attorney's Office.



Sartaria Delanette Tyson

Sartaria Delanette Tyson represented herself as a Licensed Vocational Nurse and used the credentials of "LVN" between September 28, 2014 and December 7, 2015, while employed with a home health agency in Irving, Texas. Although not initially hired in a position that required a license to practice nursing, Ms. Tyson used the credential on her name badge and business cards. Ms. Tyson was moved into a clinical position in December 2015. Ms. Tyson's employment was terminated when the agency attempted to verify her license for her new position and discovered that her license had been revoked by the Texas Board of Nursing on April 19, 2013. The case was referred to the Dallas County District Attorney's Office.

Summary of Actions

A regular meeting of the Board of Nursing was held April 21-22 2016, in Austin.
The following is a summary of Board actions taken during this meeting.



In the **May 27, 2016** issue of the *Texas Register*, the Texas Board of Nursing (Board) proposed new §211.10, relating to *Training and Education Reimbursement*. The proposed rule prescribes requirements for the reimbursement of training or education expenses for Board employees, including: eligibility requirements, employee responsibility, the obligations assumed by employees upon receiving those funds, and the requirement that the Executive Director approve education and training reimbursement. The proposed amendment may be viewed at: <http://www.sos.state.tx.us/texreg/pdf/backview/0527/0527prop.pdf>. Earliest possible date of adoption: June 26, 2016.

In the **May 20, 2016** issue of the *Texas Register*, the Board proposed an amendment to §211.9,

concerning *General Considerations*. The proposed amendment addresses the parliamentary procedures under which Board proceedings will be conducted. The proposed amendment may be viewed at: <http://www.sos.state.tx.us/texreg/pdf/backview/0520/0520prop.pdf>. Earliest possible date of adoption: June 19, 2016.

In the **May 13, 2016** issue of the *Texas Register*, the Board proposed amendments to §217.4, concerning *Requirements for Initial Licensure by Examination for Nurses Who Graduate from Nursing Education Programs Outside of United States' Jurisdiction*. The proposed amendments are necessary to treat foreign educated nurse applicants for initial licensure in Texas more similarly to individuals educated within the United States and to remove unnecessary barriers to licensure for these individuals. In the **April 15, 2016** issue of the *Texas Register*, The Board adopted amendments to §211.6, concerning Committees of the Board; §213.23, concerning Decision of the Board; §213.32, concerning Corrective Action Proceedings and Schedule of Administrative Fines; §214.8, relating to Students; and §215.8, relating to Students. The amendments were adopted without changes to the proposed text as published in the February 12, 2016, issue of the *Texas Register* (41 TexReg 1076).

Key Messages for Nursing Regulation from the National Patient Safety Foundation report *Free from Harm: Accelerating Patient Safety Improvement*

Fifteen years after *To Err is Human: Building a Safer Health System* (Institute of Medicine, 1999), patient safety concerns remain a serious public health issue that must be tackled with a more pervasive response. With a grant from American International Group, Inc., the National Patient Safety Foundation (NPSF) convened an expert panel in February 2015 to assess the gaps and review the current state of patient safety, offering detailed recommendations for continued progress in patient safety for the next 15 years. Although much advancement in patient safety has been made, the expert panel stated that efforts to enhance patient safety have “progressed at a rate much slower than anticipated”. Appreciating the fact that patient safety is far more complex than originally thought, the panel emphasized these new recommendations will require involvement of all healthcare stakeholders, including boards/governing bodies, leadership, government agencies, public-private partnerships, health care organizations, ambulatory practices and settings, researchers, professional associations, regulators, educators, the health care workforce, and patients and their families.

Additionally, because efforts in the past have focused primarily on hospitals, the panel suggested improvement efforts must be across the healthcare continuum. Patient safety must be seen as a public health issue. As the report indicates, to continue progress in patient safety and to keep patients free from harm, a commitment by all stakeholders, including nursing regulation, will be needed.

The expert panel developed eight recommendations with specific action steps, some of which may impact the regulation of healthcare and healthcare providers. These recommendations are aimed at forging a path forward in order to prioritize further improvements in the safety and quality of care. The recommendations are aimed at making fundamental, widespread improvement in patient safety and are to:

1. Ensure that leaders establish

- and sustain a safety culture;
2. Create centralized and coordinated oversight of patient safety;
3. Create a common set of safety metrics that reflect meaningful outcomes;
4. Increase funding for research in patient safety and implementation science;
5. Address safety across the entire care continuum;
6. Support the health care workforce;
7. Partner with patients and families for the safest care; and
8. Ensure that technology is safe and optimized to improve patient safety (NPSF, 2015).

The key messages for nursing regulation include:

- Although many improvements in patient safety have occurred, much work remains;
- Improvements need to be across the healthcare continuum;
- When investigations of violations of Board of Nursing (BON) Rules are initiated, there needs to be consideration of the safety culture of the organization that employed the nurse, including:
 - Full disclosure of errors when errors occur;
 - Bedside report and rounding;
 - Patient involvement in root cause analysis;
 - Active and engaged Peer Review Committees;
 - Existence of organizational patient advisory councils; and
- Public awareness of the

mission and patient safety consideration of the BON.

The eight key recommendations made by the expert panel offer an opportunity for the BON to evaluate the Board Rules, resources, and tools in consideration of current best-practices in patient safety. The crosswalk in Table 1 provides an evaluation of the Board Rules, resources, and tools that demonstrates alignment with the key recommendations made by the expert panel.

In summary, improving patient safety has become a national initiative, calling on all stakeholders, including patients and their families, to engage in ensuring a safer experience within the health care system by being an informed participant with the interdisciplinary care team. This requires continuous learning and clear communication of information among providers, organizations and patients, with the goal of promoting a safe patient care environment. Nursing regulators and nurses have a key role in improving patient safety. The BON routinely engages in the evaluation and analysis of updates and recommendations for healthcare improvement, compared to current rules and regulations for evaluation of continued pertinence and relevance, as evidenced by the NPSF recommendations and BON crosswalk. The BON remains committed to engaging in a proactive approach to nursing regulation that demonstrates integrated awareness of key environmental changes.

What do Nurses Know About *Choosing Wisely*? - What the Survey Data Reveals...

A national campaign led by the American Board of Internal Medicine, *Choosing Wisely*® is focused on educating the general public about making informed health care decisions. The campaign began in April 2012 with the goal of promoting communication that would help patients choose care that is supported by evidence, avoids unnecessary care by avoiding duplicate tests or procedures that have already been completed, does not cause harm and is truly needed to guide care. Examples of unnecessary care might include prescribing antibiotics for conditions typically associated with a virus or completing a full body diagnostic computed tomography (CT) scan for minor or single system trauma. Currently, there are more than 70 specialty society partner health care provider organizations that have released a list of tests or procedures to consider.

There are many stories about how the *Choosing Wisely*® campaign has positively impacted care provided for patients. Dr. Lokale, a family practice provider in Tuscon, AZ, shares an anecdote in which a woman presented to his practice with a cough. The patient had previously been through three rounds of antibiotics for abdominal illness and had been diagnosed with *Clostridium difficile* infection (*C. difficile*), which had eventually resolved. However, she was not aware that going on another antibiotic for her cough, which might have been viral in origin, would increase her risk for a *C. difficile* recurrence. "That suggests to me that patients' awareness of the *Choosing Wisely* recommendations is still low," he says. "Most doctors are familiar with the recommendations, but in reality, sometimes the guidelines are not followed because the patient wants treatment." When Dr. Lokale explained to the patient that taking another antibiotic would raise her risk for *C. difficile*, she readily followed his advice (DeMaio, 2015).

Texas is engaged in executing a multi-year pilot initiative focused on assessing nurses' knowledge of the *Choosing Wisely*® campaign and then educating nurses based on survey findings. Multiple stakeholders, both nationally and across the state of Texas, are involved in the successful implementation

of this pilot project. Texas participants in the project include the Texas Nurses Association, the Texas Organization of Nurse Executives and the Texas Team: *Advancing Health through Nursing*, a state action coalition focused on achieving the Institute of Medicine's Future of Nursing goals. The first step in the campaign was to develop and conduct a survey to assess the knowledge of professional registered nurses (RNs) and advanced practice registered nurses (APRNs) across the state of Texas. The survey was conducted in late 2015. Over a period of approximately six weeks, 374 nurses completed the survey. Of the participants, 295 were RNs and 79 were APRNs.

RN Survey Results

Approximately 45% of RNs that participated in the survey responded that unnecessary nursing care was a somewhat serious problem, while 52% felt a great deal of responsibility to ensure their patients avoided unnecessary care. When asked who was in the best position to address the problem of unnecessary nursing care, the overwhelming response was the RN (70%). The top three reasons that RNs identified as leading to the overuse of unnecessary care and tests and procedures include not having enough time with a patient for meaningful discussion, concern about malpractice issues, and "just to be safe".

The cost of tests and procedures are often not addressed by the RN – over half responded that the cost is never or rarely discussed. The majority of RNs (55%) believe the MD or APRN is in the best position to address unnecessary tests and procedures. According to those surveyed, 78% indicated the most effective way to address unnecessary nursing care is by using evidence based practices (EBP) but when asked to assess their knowledge of EBP, 52% indicated some knowledge with 20% indicating not much knowledge. It is encouraging that 95% are interested in learning more. Only 21% of RNs have heard of the *Choosing Wisely*® campaign.

and that the person in the best position to address the issue is the MD or APRN. The top three reasons that APRNs identified as leading to the overuse of unnecessary care and tests and procedures include concern about malpractice issues, patients insisting on getting the test or procedure, and not having enough time with a patient for meaningful discussion.

The cost of tests and procedures are often addressed by the APRN – 48% responded that the cost is often or frequently discussed. The majority of APRNs (74%) believe the MD or APRN is in the best position to address unnecessary tests and procedures. Only 26% of APRNs have heard of the *Choosing Wisely*® campaign.

Of the APRNs who have heard of the *Choosing Wisely*® campaign, 90% believe the recommendations were helpful, 67% have discussed the recommendations with their patients and all felt the information was valuable when talking to patients. Over the next 12 months, approximately half of the APRNs plan to talk to their patients often or frequently about avoiding unnecessary tests and procedures.

The next steps in the *Choosing Wisely*® campaign include distribution of education across the state at various venues. Dr. Betty Sims - A Committed Leader in Nursing Education

Nursing education and nursing regulation lost a dynamic leader with the passing of Betty E. Sims, EdD, MSN, RN, FRE on April 7, 2016. Dr. Sims' commitment to lifelong learning is evidenced in her personal educational journey, progressing from diploma nursing program graduate in 1969, completion of a baccalaureate degree in nursing in 1987, then a master's degree in nursing in 1992, and, finally, the achievement of a doctoral degree in education in 2012.

Dr. Sims' contributions to nursing regulation began in 1995 with her six-year appointment to the Board of Vocational Nurse Examiners (BVNE) by Governor George W. Bush. Following her term as a Board member, Dr. Sims served as the BVNE Education Department Chair and transitioned to the Board of Nurse Examiners (BNE) as an Education Consultant upon the 2004 merger of the BVNE and the BNE.

Also during this period, Dr. Sims was elected to the National Council of State Boards of Nursing (NCSBN) Nominations Committee and appointed to the NCSBN Education Subcommittee. In 2007, Dr. Sims was inducted as a Fellow in the NCSBN Institute of Regulatory Excellence Fellowship Program, a four-year educational and professional development program.

From 2008 to 2014, Dr. Sims served as President of the Texas Association of Vocational Nurse Educators (TAVNE). Dr. Sims' vision



and transformational leadership energized TAVNE to become an expansive and powerful voice for vocational nurse educators.

The Board appointed Dr. Sims to the Advisory Committee on Education in 2008; she was a member until 2016. Dr. Sims also served as a member of the Board Education Task Force from 2012 to 2016 and the Board Licensure, Eligibility, and Disciplinary Committee from 2011 to 2016 and was Chair from 2014 to 2016.

Throughout her professional career, Dr. Sims functioned as program director and faculty member in many nursing education programs throughout the state. These positions allowed her the opportunity to touch and shape countless lives as a colleague, mentor, counselor, and friend.

patient's friends and family members may be in a position to help the patient recognize when s/he may be unsafe operating a vehicle.

Nurses need to be aware that some of their patients may be employed in a position that requires them to operate a vehicle or heavy equipment as one of their job duties. It is important for nurses to work with their patients to recognize that a health care condition or medication may prevent the patients from meeting employment demands for a period of time. Nurses should be sure patient education includes content related to the impact of a medication or health condition on the patient's employment, recreational activities, and other aspects of the patient's life. This is particularly important for patients who are newly diagnosed with a medical or mental health condition or may be starting a new medication.

Licensure Status: Delinquent versus Inactive

A license that expires, with no communication from the nurse, becomes delinquent. The nurse must not practice nursing after the expiration of the nurse's license (NPA 301.301). When a nurse makes the decision to place the license on inactive status, prior to the expiration of the license, the nurse must notify the Board of this decision and the license is placed on inactive status. There are options for a retired or a volunteer retired license that are also forms of inactive status. For more details, please see Board Rule 217.9 and the frequently asked question (FAQ) on Volunteer Retired Nurse Authorization (in FAQs, then *Licensure* on the BON website).

Once the license is in either delinquent or inactive status, there are different applications to return the license to current (delinquent or expired renewal and reactivation form). There is a difference in the fees, with

the delinquent license application carrying a larger fee. If a nurse has not practiced nursing in more than four years, a refresher course is required. When a nurse must take a refresher course, the nurse must submit an application for a six-month temporary

permit. The permit is required to complete the clinical portion of the refresher program under the supervision of a Registered Nurse. The application forms are accessible in *Licensure* then *Renewal* and the six month permit is accessible in *Forms*.

Webinar attendance may require some advance technical preparation. Instructions and help for confirming that your workstation is compatible with the online webinar process are provided for each event. The Board also recommends joining at least 15 minutes early to ensure that you can attend the entire webinar. All of the BON CNE activities include online components that must be completed in conjunction with the activity in order to receive completion credit and certificates. When you register online, a BON Lifelong Learning Account is created and that will be your home for all BON continuing education courses, workshops and webinars.
