## Sunset Advisory Commission Decision Hearing Held on December 8, 2016

The Sunset Advisory Commission adopted decisions related to the Texas Board of Nursing (BON) Sunset Review during its meeting on December 8, 2016 at the Capitol. The Commission considered seven issues presented earlier by the Sunset Staff at the November 8<sup>th</sup> Sunset Commission hearing and one new issue presented by a Commission Member. Among the issues considered were recommendations related to:

- initial licensure requirements for graduates of nursing education programs determined not to be substantially equivalent to Texas programs;
- disciplinary standards and criminal conduct guidelines;
- improvements to the BON peer assistance program;
- adoption of the new nurse licensure compact to ensure continued nurse mobility;
- statutory clarification necessary for BON monitoring of nontherapeutic prescribing by advanced practice registered nurses (APRNs);

- statutory updates to reflect standard elements of Sunset reviews;
- a requirement for APRNs to access the prescription drug monitoring program database to review a patient's history prior to prescribing certain classes of controlled substances; and
- a continuing need for the BON to regulate nursing for 12 years.

During the 85<sup>th</sup> Texas Legislative Session set to begin on January 10, 2017, a Sunset bill including Commission decisions related to the issues will be filed by a member of the Sunset Advisory Commission. 

## Recommendations Issued from Workplace Violence Against Nurses Study

In 2016, the Texas Center for Nursing Workforce Studies (TCNWS) conducted a statewide study on workplace violence against nurses in hospitals, freestanding emergency medical care facilities, nursing facilities, and home health agencies as required by House Bill 2696, 84th Texas Legislature, Regular Session, 2015 that added Section 105.009 to the Health and Safety Code. The TCNWS Advisory Committee issued recommendations based on the study findings to:

- promote safer facilities;
- encourage nursing staffing committees to consider incidents of workplace violence;
- encourage reporting of violent events; and
- establish and maintain ongoing surveillance of workplace violence.

Between July 20, 2015 and June 2, 2016, Ramon Humberto Ortiz misrepresented himself as a licensed vocational nurse (LVN), used the title graduate vocational nurse (GVN) or LVN, and obtained employment in the San Antonio, Texas area at an assisted living facility. He did not have a GVN permit or license to practice vocational nursing. The case was referred to the Bexar County District Attorney's Office.

## Summary of Actions

A regular meeting of the Board of Nursing was held October 27-28 2016, in Austin.  
The following is a summary of Board actions taken during this meeting.



In the December 7, 2016 issue of the *Texas Register*, the Board of Nursing (BON or Board) proposed amendments to §214.3 and §215.3, relating to *Program Development, Expansion and Closure*. The proposed amendments allow the BON Executive Director to accept a nursing education program's voluntary closure without Board ratification and requires a program to wait one calendar year from the date of voluntary closure before submitting a new nursing education program proposal to the Board.

The Board also proposed amendments to §211.7, relating to *Executive Director*.

The proposed amendments to §211.7 allow the BON Executive Director to accept a nursing education program's voluntary closure without Board ratification consistent with the proposed amendments to §214.3 and §215.3, relating to *Program Development, Expansion and Closure*.

In the October 7, 2016 issue of the *Texas Register*, the Board published as adopted amendments to §217.14, relating to *Registered Nurses Performing Radiologic Procedures*. Amendments to §217.14 were approved by the Board at its July 2016 meeting and no comments were received to the proposed amendments

when published in the *Texas Register* on August 12, 2016. Amendments to §217.14 became effective on October 12, 2016.

The Board also published as adopted amendments to §223.1, relating to *Fees*. Amendments to §223.1 were approved by the Board at its July 2016 meeting and no comments were received to the proposed amendments when published in the *Texas Register* on August 12, 2016. Amendments to §217.14 became effective on October 12, 2016.



## A Nurse's Duty: Initiation of CPR

Nurses are an essential element of safe healthcare delivery and are crucial to a patient's access to the healthcare team. Assessment and reassessment are keys to identifying a potential change in a patient's condition that may require intervention to prevent a cardiopulmonary arrest. A nurse may be the first responder when a patient has a cardiopulmonary arrest. A nurse has a duty to initiate cardiopulmonary resuscitation (CPR) absent an order from an appropriately licensed provider to withhold CPR.

### Assessment

Licensed vocational nurses (LVNs) and registered nurses (RNs), including advanced practice registered nurses (APRNs), perform acts based on the specialized judgment and skills derived from the knowledge acquired in their formal nursing education program [TOC §301.002 (2) & (5)]. Nursing assessments are a key component of nursing care delivery [TOC §301.002 (2)(A) & (5)(A); and 22 TAC §217.11(2)(A)(i) & (3)(A)(i) & (4)].

The LVN collects data and performs a focused assessment of an individual [TOC §301.002 (5)(A) and 22 TAC §217.11(2)(A)(i)]. The LVN has a directed and supervised scope of practice; therefore, communication of the assessment findings to the appropriate clinical supervisor (RN, APRN, physician, physician assistant, podiatrist, or dentist) is an essential element to ensure delivery of safe patient care [TOC §301.002 (5); §301.353; and 22 TAC §217.11(2)]. [Please see Board of Nursing (BON) Position Statement 15.27, *The Licensed Vocational Nurse Scope of Practice*, for more information.]

The RN performs comprehensive assessments that are the foundation for the nursing plan of care. The initial comprehensive assessment informs the RN related to the needs of the patient. The patient needs may contribute to the frequency of reassessment. In some practice settings there may also be fac-

tors that contribute to the frequency of reassessment. These contributing factors may include laws, rules, or regulations applicable to the practice setting as nurses are required to comply with all laws, rules, or regulations applicable to the nurse's area of practice [22 TAC §217.11(1)(A)]. [Please see BON Position Statement 15.28, *The Registered Nurse Scope of Practice*, for more information.]

A nurse may always reassess a patient more frequently than the frequency required in a practice setting based on what is safest for the patient [22 TAC §217.11(1)(B)]. Patient surveillance and assessment/reassessment may identify changes in a patient's condition that may require intervention. Appropriate assessment, communication to the appropriate personnel, and intervention before the need for resuscitation could potentially prevent the need for resuscitation.

### Intervention

Nurses must be aware of the resources within the practice setting. In 2004, the Institute for Healthcare Improvement advocated for rapid response teams (RRT), and they have become widespread since then (Stolldorf, 2017, p.87-88). When examining outcomes of patients after initiation of a RRT, one retrospective study found that when there was a delay in initiation of the RRT, the patients had increased hospital morbidity and mortality (Barwise et al, 2016). In addition, patients that experienced a greater delay in the initiation and arrival of the RRT evidenced worse outcomes compared with patients that experienced a shorter delay or no delay of the RRT (Barwise et al., 2016).

All nurses are required to "institute appropriate nursing interventions that might be required to stabilize a client's condition and/or prevent complications" [22 TAC §217.11(1)(M)]. Whether this is a RRT or initiation of CPR, the nurse has

a duty to act. Just as it is imperative to promptly initiate a RRT, an essential element of cardiopulmonary resuscitation (CPR) is initiation without delay (Meaney et al., 2013).

Nurses are responsible to ensure their own continued competence in nursing practice [22 TAC §217.11(1)(R)]. As evidence evolves over time specific components of CPR or other lifesaving interventions may adapt and change. Some key components of quality CPR that have been identified include chest compressions of appropriate depth and rate while allowing full recoil of the chest between compressions and providing appropriate ventilation (Meaney et al., 2013, p. 419-420).

In order for a nurse to provide timely intervention to a patient, the nurse must assess the patient, and reassess the patient to observe any changes in the patient. Being aware of available resources and how to access or activate those resources prevents delay when the need to utilize resources is met. When there are changes in a patient's condition, the nurse must initiate appropriate interventions to stabilize the patient and communicate with the healthcare team. Whether this is initiation of a RRT or CPR, the nurse's duty is to initiate lifesaving interventions to patients.

## Advanced Nursing Roles

The 2011 Institute of Medicine report entitled *The Future of Nursing: Leading Change, Advancing Health*, advocated for the importance of advancing education in nursing. Changes in the health care environment, increasing levels of patient acuity and complexity as well as changes in technology are some of the key factors that are driving this need for advanced nursing education. As more nurses seek to advance their education, it is important to consider what this means from a licensure perspective.

The Texas Board of Nursing has licensed advanced practice registered nurses (APRNs) since the 1980s. In accordance with Section 301.152 of the Texas Nursing Practice Act, APRNs include nurses who were educated in one of four advanced nursing roles: nurse anesthetist, nurse-midwife, nurse practitioner, and clinical nurse specialist. Each of these advanced roles includes a significant direct patient care component in which the APRN provides care to individual patients in a population focus area that is congruent with the APRN's formal education. The direct patient care component includes providing nursing aspects of care as well as providing medical aspects of care under the delegated authority of a physician. As a result of this expanded scope of practice, a second level of licensure is required.

There are many other advanced nursing roles that do not require nurses to hold an additional level of licensure. Nursing administration, education, public health, informatics and research are among those areas of nursing practice that require specialized knowledge and skills at the expert level. Like the APRN roles, these are nursing roles that require additional formal education and expertise in the area of practice. However, these roles differ from the APRN roles in that they do not have the same direct care

component; therefore, an additional level of licensure is not needed for nurses who practice in these roles. This does not mean that nurses who practice in these roles do not have an effect on patient care. Nurses who practice in these roles contribute significant knowledge and expertise in key areas of nursing practice that ultimately contributes to patient care through improved patient outcomes and advancing nursing science.

Nursing as a profession involves practice at many levels in many different settings, including all of the varied advanced nursing roles. As nurses consider furthering their education to the master's or doctoral degree level, it is important to consider whether they wish to engage in an advanced role that requires an additional level of licensure. All advanced nursing roles are vital to the health and well-being of patients and to the advancement of the nursing profession.

# The Benefits and Limitations of Nursing Continuing Education

The U.S. health care system is undergoing significant transformation focused on achieving the Triple Aim, an initiative targeted at improving the patient's experience, the quality, and the cost of healthcare (Institute for Healthcare Improvement, 2016). With the passage of the Affordable Care Act and subsequent state and federal health care legislation, augmented by significant contributions from major health foundations and philanthropies, our nation is working to create the right foundation for population health, managing services, controlling cost, and establishing a learning system to drive and sustain the work over time (Whittington, Nolan, Lewis, & Torres, 2015).

Nurses, including advanced practice registered nurses, are the largest group of health care providers in the nation and the most trusted by consumers (Gallup, 2015). As the largest group of health care providers, nurses are key to improving access to care and the quality of care through educational achievement that is evidenced in clinical expertise. The current nursing shortage projected for 2015-2030 reveals that Texas will face a shortage of all nurse types by 2030 (Texas Center for Nursing Workforce Studies, 2016). As nursing vacancies abound, it is crucial that nurses understand the benefits and limitations of continuing education.

Nurses are responsible for working collaboratively with supervisors and colleagues to ensure patient safety. Nurses are accountable to the public to ensure competency, linking with important implications for continuing education. Lifelong learning and a concerted continuous effort toward personal growth and development positively impact teamwork, contributing to the achievement of the Triple Aim and quality patient outcomes (Ammouri et al., 2014).

The *Standards of Nursing Practice* applicable to all levels of nursing licensure outlined in Texas Board of Nursing (Board) Rule 217.11(1) promote concepts integral to patient safety and the importance of nursing knowledge and accountability impacting safe, competent, quality patient care. The rule requires each nurse to promote a safe environment for clients

and others through collaboration, and obtaining instruction and supervision to ensure safe, competent practice [22 TAC §217.11(1)(B)(G)(H)(P)(R)]. Continuing competency in an ever-changing health care environment is crucial to safe patient care. It is the responsibility of all nurses to attend to professional growth and development activities, ensuring safe patient care delivery that is up to date and representative of current evidence-based practices.

The Board believes that completion of on-going, informal continuing education offerings, such as workshops or on-line offerings in a specialty area, serve to expand and maintain the competency of the nurse at his/her current level of licensure. Nurses engage in lifelong learning that influences best practices, including evidence-based decision making, thus contributing to improved quality of patient care. The technical skills and critical thinking that nurses deploy at the bedside are not enough, in isolation, to sustain an evidence-based practice environment.

Continuing education can be a tool, in conjunction with organizational and individual factors, that positively influences innovation and successful implementation of evidence-based practices (Yost et al., 2015). However, continued competency and improving professional skill and expertise has licensure related limitations. No amount of informal or on-the-job training can qualify a nurse at any level of licensure to engage in practice that is designated in statute or rule as being exclusive to the next level of licensure. The Board believes that for a nurse to successfully make a transition from one level of nursing practice to the next requires the completion of a formal program of nursing education leading to the appropriate level of licensure.

Contained in the *Future of Nursing* report, the Institute of Medicine (2011) stated, "To respond to the demands of an evolving health care system and meet the changing needs of patients, nurses must achieve higher levels of education and training". All nurses need to advocate for inclusion of the profession in emerging care delivery models by demonstrating the educa-

tion, knowledge, skill, and expertise to assume roles that improve patient care and quality. Nurses are bedside leaders, patient advocates, and champions. Nurses that focus on continuous learning and professional growth and development will be best poised to deliver evidence-based patient care and to contribute nursing knowledge and expertise to the evolution of the health care system.

Nursing peer review is based within an employment setting. An employer must hire, employ, or contract for the services of 10 or more nurses to be required to establish a nursing peer review committee [Texas Occupations Code (TOC), Section 303.0015 (a)]. For peer review to extend to RNs, at least 5 of the 10 nurses must be RNs [TOC Section 303.0015 (a)(2)].
